I understand that I am bound by the Crean Hill Gun Club By-laws, current Chief Firearms Office Range Approvals and the club Range Rules. If I require a copy of the by-laws, Chief Firearms Office Range Approvals or the club Range Rules, I can obtain them from the club web-site or by emailing info@creanhillgunclub.ca I understand that I am responsible to take part in shooting, acting as an official or other club activities including working on the club property having regard to my own state of health, previous firearms, work or life experience.
